Gentlemen:

We your Administration and Operations Committee recommend approval of an agreement between the County of Midland Department of Public Health and Harold Alexander, Inc. regarding groundwater restrictions near 815 Ashman Street in Midland, Michigan. This is a one-time agreement.

This agreement was prepared jointly between the representatives from the Michigan Department of Environmental Quality ("MDEQ"), Harold Alexander owner's representative, Charles Barbieri of Foster, Swift, Collins; the County Health Director, the County's Civil Counsel and others. This agreement prohibits or restricts the use or installation of wells within the established geographic area surrounding the Harold Alexander property. The Restricted Zone has groundwater contamination in this area. Any relief from the prohibition would require involvement with the MDEQ and the County.

Adjacent property owners have been notified of the proposed action by the owner's representative using certified mail. In addition significant testing has been conducted regarding water quality and the MDEQ has been active in reviewing those results. Based upon available data it is believed that the contamination is confined to the Restricted Zone.
