Maps showing treatment areas to all Board Members. Shallow area had algae,  
27 and 30 area on East side—milfoil. Twin Lakes area quite a bit in the  
canals. Sonar Treatment seems to be working good. Couple spots on West side  
Muddy Bay area showing good results. Passed out project Work Journal and  
Invoices for work done was presented.

for \$6,215.66 for a Total of \$65,464.48. Motion by Dennis McBride to pay and

LARRY WOODARD advised the Board that Hay Township has expressed interest in Weed Control.  
Hay Township Board will have to do a Resolution and have Public Meetings. They will have  
to assess property Owners and funds would have to be funneled through our Association. It

perked. There is plenty of access on Lake.


